Executive Protection Case Study

Executive Protection: Safeguarding Revenue and Reputation

The Challenge

A senior executive was traveling internationally without a formal executive protection structure in place.

A targeted security incident disrupted business operations and forced the organization to pause international travel.

This led to delayed transactions, financial losses, increased insurance scrutiny, and raised concerns at the board level about leadership exposure and risk governance.





Results

We established a structured executive protection program with standardized global travel risk protocols, real-time intelligence for trip planning, and risk-based deployment of protective teams alongside a formal crisis response framework.

This enabled safe resumption of international operations, driving a 20% increase in revenue, 11% improvement in executive retention, 14% reduction in liability premiums, 23% boost in customer service performance, and restored board-level confidence in leadership protection and governance.

The Challenge

During the 2021 and 2025 New York City mayoral races, the candidate participated in rallies, public events, and high-profile media appearances that required robust security measures.

The dynamic campaign environment created elevated exposure risks while maintaining the need for open public engagement and constant visibility.



Results

We managed comprehensive executive protection operations by coordinating closely with campaign staff, law enforcement, and venue security teams to ensure layered protection without restricting accessibility.

This enabled the candidate to engage freely with the public, maintain strong media presence, attend all scheduled events without disruption, and sustain campaign momentum within a secure operating environment throughout the election cycle.



Executive Protection & Secure Transportation: Mexico Operations

The Challenge

Operating in Mexico's high-risk environments since 2008 required delivering executive protection and secure transportation services where safety threats, reliability concerns, and operational uncertainty posed significant risks to corporate clients and leadership mobility.



Results

We implemented robust, location-specific security protocols and delivered discreet, professional protection and transportation services tailored to Mexico's unique risk landscape.

Over 15+ years of continuous operations, we maintained a flawless, incident-free track record, strengthened corporate confidence, ensured seamless executive mobility, and established a trusted standard for excellence in high-risk environments.



Corporate Espionage Case Study

Advanced Persistent Threat: Contained and Neutralized

The Challenge

The chairman was targeted with a highly coordinated spear-phishing attack across multiple geographies.

The attack exposed executive communications, intellectual property, strategic discussions, and deal flow to corporate espionage, elevating the risk of competitive intelligence theft and operational disruption.



Results

We conducted a forensically sound investigation, reverse-engineered the malware, mapped threat vectors, traced the attacker's global network, and coordinated intelligence with law enforcement.

This neutralized the threat, secured intellectual property, prevented brand dilution, reduced IT costs by 14%, strengthened internal cyber governance, and enhanced client acquisition through improved security credibility.



Data Center Relocation: Zero Downtime Achieved

The Challenge

Relocation of a 25-year headquarters and two legal offices mid-week posed high risks of internet and corporate email disruption, complex vendor coordination, and significant cost exposure from traditional migration methods.

Solution & Results Summary

We designed a virtualization-driven continuity plan, executed parallel network staging, oversaw phased physical relocation, and coordinated vendors with internal IT.

This resulted in zero downtime, migration completed at 40% of projected traditional cost, seamless consolidation of operations, and industry recognition for continuity excellence.



Enterprise Disruption Threat: Modeled and Neutralized

The Challenge

Distributed Interruption of Service (DISO) risks, hosting concentration vulnerabilities, and cloud/virtualization dependencies threatened enterprise continuity.



Solution & Results Summary

We developed a cyber defense checklist, conducted infrastructure distribution analysis, and performed cross-sector resilience assessments.

This strengthened systemic service resilience, extended threat modeling, and institutionalized enterprise continuity strategies.



Intellectual Property Theft: Identified and Neutralized

The Challenge

A former sales executive joined a competitor, stealing customer databases and proprietary data, threatening revenue, competitive advantage, and intellectual property

Solution & Results Summary

We conducted a forensic examination, coordinated legal seizure of assets, and recovered stolen data.

This stopped revenue decline, achieved 16.7% revenue growth, 2.7% profit increase, 9.8% productivity improvement, 22% stock value increase, and prevented counterfeit market impact.



Global Risk Exposure: Standardized and Secured



The Challenge

30+ manufacturing facilities in Mexico and Central America faced inconsistent plant configurations, cross-border operational vulnerabilities, and exposure to physical, environmental, insider, and supply chain threats.

Solution & Results Summary

We performed security gap analysis, customized protective matrices, delivered bilingual training, integrated counter-surveillance, hardened infrastructure, and established quarterly audits.

This strengthened plant resilience, improved supply chain security, standardized governance, and maximized protection efficiency.



Workforce Threat Exposure: Contained and Controlled

The Challenge

Phone threats surged during recession-driven activity with no structured policy, reducing morale, operational focus, and productivity across call centers.

Solution & Results Summary

We implemented a 24/7 threat response hotline, validated threats immediately, coordinated with law enforcement, and institutionalized structured investigation and prevention protocols

This achieved a 10% productivity increase, 11% absenteeism reduction, 7% customer service improvement, and strengthened workforce morale and recruitment efficiency.
